

### STUDENT LOAN DEBT REDUCTION AWARDS

The SEMVMA is proud to announce that we will be awarding two \$2500 awards to recent graduates during the January Membership Celebration Dinner to reduce their student debt. This grant will be awarded to two members who meet specific requirements. We intend to choose 2 recipients per year who meet the following requirements:

- Have graduated in the last 3 years (2023, 2024, 2025)

### ANESTHETIC AND ANALGESIC MANAGEMENT OF BRACHYCEPHALIC BITCHES PRESENTING FOR AN EMERGENCY CESAREAN-SECTION

This summary article focuses on the anesthetic management of dystocias in brachycephalic bitches, and not on the medical management or physiological changes that occur during pregnancy.

As the popularity of brachycephalic dogs increases, and with the likelihood of these animals presenting with a dystocia at one or multiple times in their lives, it is important to understand the additional steps that should be taken when managing their anesthetic event. It is critical that the time spent under anesthesia is minimized in an attempt to improve the survivability of the bitch and the puppies.

On presentation, it is important to obtain and perform the following: a signalment, full history, physical examination which should include a vaginal examination, a pain score using an objective pain scoring scale, and a CBC and biochemistry panel if indicated. The additional time taken to perform diagnostic imaging, at the time of an emergency presentation, such as abdominal radiographs and ultrasound could lead to a lower APGAR score – a lower survivability of the puppies at birth. The decision to perform additional tests would also be based on if this is a new patient or if the bitch has been routinely seen throughout her pregnancy at your clinic. However, it is up to the clinician to decide if one or more of these tests are warranted to assist with making the decision to take the bitch to surgery.

### Sample anesthetic and analgesic plan:

As far as the author is aware, there are no studies demonstrating the safety of cerenia (maropitant) in pregnant bitches and is therefore generally not used in these cases. Metoclopramide, a prokinetic, is sometimes used in brachycephalics in an attempt to reduce the risk of regurgitation and aspiration during the anesthetic event. The use of this drug in these cases is controversial and clinical judgement should be used to assess its benefit in each case. Additionally, studies have shown that oral administration of metoclopramide, after delivery of the puppies, was helpful in stimulating milk lactose production in the bitch.

**Pre-anesthetic period:** The surgical site should be clipped and prepared as much as she will allow prior to the induction of general anesthesia. This is done to limit the amount of time that the puppies are exposed to the anesthetic drugs.

It is important that these animals are preoxygenated for about 3 to 5 minutes prior to induction. The benefit of this is to fill the functional residual capacity (FRC) in the lungs with about 100% oxygen. This will provide the bitch with a limited supply of oxygen for her and her puppies to utilize if she becomes apneic during induction or if intubation is challenging and takes longer than anticipated. Since these animals are often not premedicated prior to induction of general anesthesia they may not tolerate a tight fitting oxygen mask over their face. If she resists preoxygenation, the mask should be slowly moved away from her face to the point that it is tolerated. Fighting with the bitch to keep the mask on its face is likely to increase the bitch's stress level and may therefore not provide the intended benefit.

**Premedication:** Most often, these animals are not premedicated as anesthetic drugs will cross the placenta and potentially decrease the survivability of the puppies.

**Induction of general anesthesia:** Two main drug recommendations for induction of general anesthesia are alfaxalone 1 to 2 mg/kg or propofol 2 to 5 mg/kg, administered intravenously to effect. Always have more of the induction agent available as it may be needed during the intubation and maintenance periods.

A laryngoscope should always be used to help facilitate intubation, but especially so in brachycephalic animals. This will allow for proper visualization of the oral cavity as these breeds can sometimes be challenging to intubate. There is also the increased risk of regurgitation and aspiration, associated with the physiological changes that occur during pregnancy, which is why a fast and safe intubation is so important in these pregnant bitches. At least three sizes of endotracheal tubes (ETTs) should be selected, with the middle size being the one that is thought to be the ideal size for the bitch. It is important to remember that the size of ETT needed for a brachycephalic animal will often times be smaller than that needed for a non-brachycephalic breed of a similar size and weight.

A bougie, or flexible stylet, should also be available to help improve the intubation process. The bougie should be placed inside the ETT with about 2 to 3 inches protruding from the end of the ETT. This technique usually makes the intubation process easier as compared to attempting to intubate these animals with only a laryngoscope and an ETT.

After the surgical site is fully clipped and prepared, a line block should then be performed on midline along the incision line. A skin incision is very stimulating and may cause the bitch to be reactive, especially since she would not have received any analgesics up to this point. Local anesthetic drugs such as lidocaine, ropivacaine or bupivacaine can be used for this block. Caution is recommended when performing a line block in pregnant bitches as there are many dilated blood vessels in this area, and systemic administration of ropivacaine or bupivacaine can be detrimental. As always, be sure to calculate the appropriate dose and be aware of the toxic dose of the drugs used. Due to the urgency of delivering the puppies in a timely manner, lidocaine is often used because of its fast onset of action which will allow surgery to begin shortly after its administration. It does however have the shortest half-life as compared to the other local anesthetics, so the effect of the block will not last as long.

**Maintenance of general anesthesia:** Sevoflurane or isoflurane in 100% oxygen. Intravenous fluids (Lactate Ringer's Solution) at an infusion rate of 3 to 5 ml/kg/hr.

Additional doses of alfaxalone or propofol should be available in case the bitch becomes "light" under anesthesia due to the effect of surgical stimulation. Increasing the percentage setting on the vaporizer is not recommended if the bitch becomes "light" as the time it takes for the concentration of the inhalant to change in the system can be about 5 to 10 minutes (time constant of an anesthetic inhalant). Analgesic options and considerations: Analgesics can be administered intravenously after all of the puppies have been delivered. Analgesic options consist of either a pure-mu agonist such as hydromorphone, morphine or methadone, or a partial-mu agonist such as buprenorphine. The choice is usually based on clinician preference and availability of analgesics. Pure-mu opioid agonists are often preferred due to their higher efficacy as compared to a partial-mu agonist, but their duration of action is shorter and can cause more sedation.

Subcutaneous and/or oral administration of nonsteroidal anti-inflammatory drugs are based on clinician preference. Studies have shown that carprofen was safe to be administered to lactating bitches, however caution should be taken in bitches with mastitis as the concentration of carprofen in the milk from the teats with mastitis was higher than those without mastitis.

An epidural can also be performed but it should be done after the puppies have been delivered and not before, as this would lengthen the amount of time that the bitch is under anesthesia and therefore increase the amount of time that the puppies are exposed to the effect of the anesthetic drugs. The choice of drugs used for the epidural could affect the time to discharge and it is generally recommended that only morphine preservative free (PF) be used as this will only affect sensory function as compared to adding a local anesthetic. If motor function is blocked, with the use of a local anesthetic, then the bitch will not be able to use her hindlimbs and would need to be hospitalized until she regains use of all four limbs.

**Recovery:** The bitch's oral cavity should be suctioned before extubation. This is performed to remove any regurgitated material to reduce the risk of aspiration once the bitch's airway is no longer protected by the presence of the ETT.

**Outcome:** The goal, once the bitch and puppies are doing well, is to discharge them as soon as possible to reduce the risk of the puppies acquiring nosocomial infections and also to return the bitch to her familiar surroundings so that she can begin taking care of her puppies.




