## DERMATOLOGY

Dr. Elizabeth Layne

Dr. Elizabeth Layne is a 2002 graduate of the Colorado State University College of Veterinary Medicine. She worked in both mixed and small animal practice in her home state of Montana before pursuing dermatology specialty training in 2011 in Wisconsin. After 6 years at the UW-Madison School of Veterinary Medicine as both a trainee and an instructor, she moved to private specialty practice in Salt Lake City.

**Some of the topics Dr. Layne will discuss include:**

The Dermatology TPR Skin vital signs are critical for dermatology decision-making. With case examples, learn how to confidently obtain samples and use your microscope to quickly run through your differential diagnosis list. Update on Feline Atopic Dermatitis part 1 and part 2. This 2-part lecture will use case examples to cover the guidelines published in 2021 by the International Committee on Allergic Diseases in Animals (ICADA). The Frustrating Atopic Dog - With so many options for managing allergic skin

disease in dogs, it can be challenging to get the treatment plan right for each patient. Case-based discussion will cover common pitfalls and some of the more difficult-to-manage problems. Nutritional Dermatoses - These unique skin diseases can have clinical signs that overlap with more common skin problems. Learn how to differentiate these. Also brief discussion of nutritional support for epidermal barrier function for both nutritional and non-nutritional dermatoses. A Dermatology Disaster Walks in to the ER - For emergency clinicians and general practitioners alike, how to address the owner's urgent concern, and set the pet up correctly for the next steps. Phone a Friend! - Fast and light-hearted run through a variety of case questions asked by colleagues of their dermatologist friend. What do I do with this culture result? Now what with this ear? Should I biopsy this? Is topical therapy alone ok for this lesion?



## URINARY

Dr. Larry Adams

Dr. Larry Adams is a Professor and Section Head, Small Animal Internal Medicine Veterinary Clinical Sciences, Purdue University. He became a Diplomate of the American College of Veterinary Internal Medicine, in 1991. Dr. Adams career has been focused on clinical nephrology and urology with emphasis on minimally invasive endourology procedures and treatment of refractory cases. Feline renal diseases: case-based lecture. Urinary obstruction: Newer options for treatment. Acute kidney injury or Addison's Disease? This is a case-based lecture.

**Some of the topics that Dr. Adams will discuss include:** Veterinary Treatment of UTI – Guidelines for sporadic and recurrent UTI. Hemodialysis for Acute Kidney Injury (AKI) and Intoxications – What is new for the practitioner? Management of uroliths in the lower urinary tract – Alternatives to cystotomy. Urinary incontinence – Diagnosis and treatment of refractory cases. Urinary obstruction: Newer options for treatment. Acute kidney injury or Addison's Disease? This is a case-based lecture.

## RESPIRATORY

Dr. Stephan Carey

Dr. Carey is an Associate Professor, Small Animal Internal Medicine at MSU. He completed an internship and then residency at Michigan State University. He has a PhD in Comparative Medicine and Integrative Toxicology and is a Diplomate, American College of Veterinary Internal Medicine (SAIM). Dr. Carey's clinical interests include canine and feline upper and lower airway disease, infectious respiratory disease, and evaluation of the role of environmental exposures on companion animal airways. His research interests are directed toward the investigation of comparative lung and upper airway structure and development, and on the effects of environmental exposures on the developing respiratory system.

**Some of the topics Dr. Carey will discuss include:** Canine Chronic Bronchial Disorders: Medical Management and Complications. Medical Management of Brachycephalic Obstructive Airway Syndrome. Medical and Alternative Management of Feline Chronic Rhinitis. Medical and Interventional Management of Canine Tracheal Collapse.

Canine Infectious Respiratory Disease Complex: Pathogenesis, Prevention, and Outbreak Management.

has been accepted for a position in the Thomas P. Sollecito One Health Fellowship, a program focusing on oral medicine in both the human and veterinary model.

His areas of interest are maxillofacial trauma repair and oral oncologic surgery. Outside of the profession, he enjoys working on his hobby farm with his wife, Laura and practicing Brazilian Jiu Jitsu.
